Strengthening the Membership of the Peacemakers Network

In 2024, the Steering Group confirmed and proudly welcomed seven new members to its membership: the Association for the Welfare of Women and Indigenous People, Canadian Friends Service Committee, Enable the Disable Action, Interfaith Dialogue Forum for Peace, Nepal Unites, Pakistan Council for Social Welfare and Human Rights, and Re-Imagining New Communities.

These organizations bring a wealth of diverse experiences that enrich the Peacemakers Network's collective expertise and strengthen its membership strategy. Representing traditional actors, women-led and youthled initiatives, and persons with disabilities, their unique perspectives and expertise are instrumental in advancing shared goals and fostering impactful partnerships for sustainable peacebuilding initiatives.



Members and Supporters Convene to Launch Strategy Renewal

Throughout the Fall of 2024, a series of regional and country-level strategic consultations were held to evaluate the impact of the Peacemakers Network 2020-25 Strategy and shape the next strategic framework for 2025-30. These consultations, a shift from the traditional global Advisory Group Meeting, aimed to deepen localized engagement, strengthen partnerships, and foster greater ownership of the new strategy. Co-hosted by members, the consultations were held in: Nairobi, Kenya; Abuja, Nigeria; Washington, DC, USA; Bangkok, Thailand; and Helsinki, Finland. A final global virtual meeting was held in December.

Through collaborative discussions, participants shared experiences, provided feedback on strategic priorities, and identified opportunities to enhance the Peacemakers Network's role in fostering peace in a multipolar world. Members and partners in Nairobi emphasized innovative resource mobilization, inclusive governance, building local capacities, and enhancing trust while in Abuja, conversations focused on Nigeria's complex conflicts, advocating for interfaith and intra-faith dialogue, and women and youth inclusion in peace processes.

In Washington, DC, members and supporters underlined the importance of engaging religious and traditional actors in peacebuilding and addressing the gaps in defining religions and traditional actors, integrating civic education and intergenerational dialogue in peace initiatives.

In Bangkok, conversations resulted in recommendations in the Peacemakers Network's thematic areas of focus to include peace mediation, dialogue, and reconciliation; deepening inclusivity in peacebuilding through research and analysis; preventing and countering violent extremism, particularly state violence in authoritarian regimes; and advancing environmental stewardship and climate security as an emerging priority.





In Helsinki, members raised the importance of continuing evidence-based programming and proposed prioritizing support for young peacemakers and intergenerational dialogue, climate-induced conflicts and mental health and trauma-informed approaches in peacebuilding.

The 2024 consultations concluded with a virtual global meeting, where members highlighted the need for joint advocacy and amplifying the voices of youth.

Collective Action for Sustainable Peace and Collaboration with the United Nations

Building Partnerships for Peace: Finnish Ambassador Hosts Peacemakers Network's Annual Steering Group Meeting

Hosted by the Finnish Ambassador to the United Nations Elina Kalkku in New York, the annual principal-level Steering Group meeting convened in May 2024, reaffirming the importance of collaboration in advancing the Peacemakers Network's mission. Representing the Steering Committee, the Ministry for Foreign Affairs Finland, United Nations Support Unit, Finn Church Aid, KAICIID, the Organization of Islamic Cooperation, United Nations Women, United Nations Development Program, United Nations Population Fund, and the United Nations Office for the Prevention of Genocide convened to review the Peacemakers Network's 2020-2025 strategy, amplify the meaningful inclusion of women and youth, and strengthen partnerships with traditional actors in peace mediation.

Continued Multi-Faith Collaboration for Peace and Security

The Peacemakers Network, alongside fellow Co-Chair member of the Multi-Faith Advisory Council (MFAC), Buddhist Tai Chi Foundation, and in coordination with the UN Interagency Task Force on Religion and Sustainable Development (IATF-Religion), UN Population Fund, the UN Alliance of Civilizations, and the UN Office of the Special Advisory on the Prevention of Genocide, organized the first MFAC-IATF meeting for 2024



at the Baha'i International Community in New York in January 2024. Participants reflected on the collaborative efforts conducted throughout 2023, sharing challenges and lessons learned.

2024 United Nations Commission on the Status of Women in New York

Throughout the 68th session of the Commission on the Status of Women (CSW) in March 2024, the Peacemakers Network and its partners held three events showcasing women's empowerment through tackling poverty and improving institutions and financing with a focus on gender:

Funding the Backlash or the Revolution? Rights, Religious, and Resistance Held as an official side event, this discussion focused on how anti-rights actors are evolving into well-funded movements while progressive movements remain under-funded and left behind. It was organized in partnership with the Global Interfaith Network (GIN-SSOGIE), the ACT Alliance, Act Church of Sweden, and co-sponsored by the United Nations Population Fund (UNFPA), Sweden, Canada, and Germany.

Financing Peace for Gender Equality: Advancing the Financing of the 1325 Agenda

In partnership with the United Religions Initiative (URI), Soka Gakkai International, NGO CSW, and Women in International Security (WIIS), this event focused on what next steps and reforms needed to be taken to refinance reforms aimed supporting peacebuilding and women's rights organizations that led up to the 25th Anniversary of the 1325 Women, Peace and Security Agenda. Discussions stressed the importance of more inclusive and flexible funding allocation, especially directly towards women-led and focused peacebuilding organizations.

The Role of Faith Actors and Institutions in Promoting Gender, Peace and Security

Partnering with the Centre for Gender in Politics at Queen's University in Belfast, Christian Aid, the Global Interfaith Network (GIN-SSOGIE), the ACT Alliance, and Act Church of Sweden, focused on how to strengthen partnerships and understanding between faith and LGBTQ+ movements and communities through utilizing the Queering the Women, Peace and Security Toolkit.

Enhancing Indigenous Peoples' Rights to Self-Determination at the 23rd Session of the **United Nations Forum on Indigenous Issues**

In April 2024, the 23rd Session of the UN Forum on Indigenous Issues, the largest global gathering of Indigenous actors, convened at UN Headquarters under the theme "Enhancing Indigenous Peoples' Right to Self-Determination in the Context of the United Nations Declaration on the Rights of Indigenous Peoples: Emphasizing the Voices of Indigenous Youth."



This year, the Peacemakers Network convened two tailored activities designed to support Traditional and Indigenous leaders in peacebuilding and sustainable development. These engagements reinforced the Peacemakers Network's commitment to supporting Indigenous advocacy by fostering collaboration, amplifying Indigenous voices, and advancing actionable outcomes aligned with the forum's recommendations.

JISRA Youth Advocacy Mission to the UN High Level Political Forum

In building upon the imperative role of youth, the Joint Initiative for Strategic Religious Action (JISRA), a five-year Dutch funded consortium organized a youth advocacy mission to New York during the United Nations High Level Political Forum (HLPF) in July 2024. The JISRA youth delegation hosted a side event that explored 'Bridging Divides and Building Peace - Youth, FoRB, and the SDGs' which provided a platform for youth to share challenges and opportunities of young people from diverse religious, cultural, and geographic backgrounds.

United Nations Religion and Mediation Course: Focus on the Americas

The United Nations Religion and Mediation Course (UNRMC), supported by the Ministry of Foreign Affairs of Finland, the Swiss Federal Department of Foreign Affairs, CSS/ETH Zurich, the United Nations Department for Political and Peacebuilding Affairs (UNDPPA) Mediation Unit, and the Peacemakers Network, plays a vital role in enhancing mediation efforts through a lens of inclusion and religion.

This year's program focused on the Americas, utilizing an innovative hybrid approach, beginning with three half-day online training sessions and culminating in a three-day in-person workshop in October 2024 in Bogotá, Colombia. By exploring the narratives around conflict drivers, points of disputes, and historical peacebuilding processes, the course provided participants with tools to address complex challenges in Colombia, Bolivia, and Ecuador. With its emphasis on integrating religious dimensions into mediation, the UNRMC empowers mediators to foster inclusive dialogue and build sustainable peace in diverse and multi-faith communities.



Faith, Ethics, and Artificial Intelligence (AI): Shaping a Future for Global Peace

As part of the UNGA side event, the MFAC hosted a discussion on the ethical implications of AI in peace and security. Experts stressed the need for transparency, accountability, and faith-based engagement in Al development, particularly regarding autonomous weapons. Speakers highlighted the risks of removing human oversight, the push for legal regulations, and the role of diverse perspectives in shaping ethical AI. The event underscored the vital role religious leaders in ensuring technology aligns with moral and humanitarian values.



New Toolkit! Development of Islam and FoRB Toolkit: Guide for Inter-Religious Action Practitioners


Since 2023, the global Joint Initiative for Strategic Religious Action (JISRA) consortium has promoted freedom of religion and belief (FoRB) across seven countries including Ethiopia, Indonesia, Iraq, Kenya, Mali, Nigeria, and Uganda.

In recent years, identity-based conflicts, particularly those centered around inter-and intra-faith tensions, have exponentially increased worldwide. This rise is partly due to high population growth rates, porous borders, and deteriorating security conditions, leading to mass displacements and severe humanitarian crises. A new toolkit was designed for FoRB practitioners, peacebuilders, and policymakers committed to promoting gender equality, mutual respect, and interreligious dialogue.

Funded by the Dutch MFA, the JISRA consortium is composed of members including TearFund, Search for Common Ground, Faith to Action Network, and led by Dutch NGO Mensen Met een Missie.


Training Launch: Religion, Peace Mediation and Leadership for Women Faith-Based **Mediators**

In May 2024, a training was held in Accra, Ghana, on religion, peace mediation and <u>leadership for women and young women of faith-based mediators</u> (WFBM) from Ghana, Nigeria, and Cameroon. Hosted alongside the Center for Women, Faith and Leadership and the Sanneh Institute, participants strengthened their personal leadership, acknowledged personal compassion fatigue and vicarious trauma, and unpacked the dynamics of gender, religion, and mediation, and highlighted the important role of male allyship in advancing the leadership of WFBMs.



Women faith-based mediators and negotiators are defined as those, 'who are working on various tracks for ceasing violence and finding agreements in order to prevent and mitigate violence. In doing this work, their tools and methods are inspired by faith, and/or they are cooperating within or with faith-based structures and/or with faith-based actors, and/or are gaining motivation and inspiration for this work through faith.' The training was designed to address the capacity-building needs as identified in the Berghof Foundation and the Peacemakers Network's WFBM study 'Under Crossfire: The Courageous Work of Women Faith-Based Mediators to Prevent, Mitigate and Resolve Violent Conflicts.'

Interfaith Dialogue on Violent Extremism (iDove)

Throughout 2024, Interfaith Dialogue on Violent Extremism (iDove) programme provided an intercontinental platform of exchange and learning for youth working on preventing and countering violent extremism and building social cohesion.

Through this initiative, four small grants were awarded across six countries in Africa that embraced a gender transformative approach to preventing and countering violent extremism (P/CVE). From empowering young women in Nigeria, challenging harmful gender norms in the Democratic Republic of Congo, amplifying youth to prevent violent extremism in the region of Liptako Region, to promoting gender inclusivity in Kenya, these projects have fostered resilience and inspired transformative change.

Through the support of the African Union Citizens and Diaspora Directorate (CIDO) and Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ-Gmbh), iDove Intercontinental Youth Forum convened in November in Accra, Ghana, focusing on finalizing the governance structure of iDove and on the thematic training topic of religion and peace mediation.

Youth, Religion and Mediation Course in Muscat, Oman

The third youth cohort participated in the Harmonious Connection Program, hosted in Oman and supported by the Ministry of Endowments and Religious Affairs of the Sultanate of Oman, and the Peacemakers Network's Youth, Religion and Mediation course held, in partnership with the United States Institute of Peace (USIP). The program maintains an opportunity to bring young leaders from all over the world to foster interfaith mutual understanding, coexistence, and peace.

Stories for Peace and Social Cohesion

As a final product from the concluded Interreligious Dialogue for Peace and Social Cohesion (ID-Peace) project in Mozambique, a new toolkit, 'Stories for Peace and Social Cohesion,' was designed for peace practitioners and mediators to better understand different conflict perspectives from the perspective of six illustrated stories. The stories tell trueto-life experiences with conflict, displacement, inter-religious dialogue, and how everyone can act to build peace and community cohesion. The ID-Peace project seeks to reduce inter-and-intra communal tensions and related religious freedom abuses by strengthening social cohesion and religious tolerance in Mozambique. English versions are available for wider use across the globe.

Diplomatic Briefing and Networking Event in Maputo Showcases Peacebuilding Achievements and Future Opportunities

The Peacemakers Network has been actively promoting social cohesion, religious tolerance, and increasing capacity of civil society actors to address natural resourcebased conflicts in Mozambique. In May 2024, a diplomatic briefing and networking event was held in Maputo, hosted at the Embassy of Finland, bringing together ambassadors and political advisors from Sweden, Portugal, Germany, France, Finland, and the European Union delegation. The briefing highlighted peacebuilding achievements, including findings from the Towards Inclusive and Peaceful Societies (TIPS) project evaluation, conflict mapping and community training under the Community Social Cohesion (CSC) project, and the development of advocacy materials for the Interreligious Dialogue for Peace and Social Cohesion (ID-Peace) project, while exploring opportunities for continued programming for 2025 and beyond.

Ringing the Bell for Peaceful South Sudan and Supporting Religious and Traditional Actors on their **Peacebuilding and Election Preparedness**

In March 2024, the Peacemakers Network, in partnership with Finn Church Aid's South Sudan Country Office and the South Sudan Council of Churches (SSCC), convened 30 participants in Juba, including religious leaders, women, and youth of faith, to address the now postponed 2024 election, and strategies and strategies for deescalating tensions. The workshop, supported by the Ministry of Peacebuilding Undersecretary, strengthened the role of religious leaders in local peace processes and inspired the Bureau for Religious Affairs to organize a consultative meeting on national dialogue initiatives.

Building on this effort, two policy briefs were developed presenting key findings and recommendations from religious and traditional leaders to national stakeholders and the international community, 'Preparing for Inclusive and Peaceful Elections in South Sudan' and 'Ringing the Bell' a Call for Peaceful <u>Elections in South Sudan'</u>. These briefs have been shared at various advocacy events, including the National Dialogue Forum in Helsinki, Finland, and meetings with the EU Special Representative for the Horn of Africa, the EU Foreign Policy Instruments (FPI) Regional Focal Point for South Sudan and the UN Commission on Human Rights South Sudan.





Supporting Religious Leaders in their **Contributions to** Dialogue, Mediation and **Peacebuilding in Sudan**

At the start of 2024, the Peacemakers Network, in partnership with United States Institute of Peace (USIP), facilitated a strategic discussion on the role of religious actors in mediating peace in Sudan, ensuring inclusive participation of youth and women alongside traditional leaders. Held alongside a regional peer-learning event organized by USIP, Inclusive Peace, and the African Council of Religious Leaders Religions for Peace (ACRL-RfP) in Nairobi, the convening set the stage for a two-day meeting in Juba in March 2024. This meeting brought together Sudanese and South Sudanese religious leaders, resulting in a collaborative roadmap with actionable steps to advance peace and end the conflict in Sudan.

Sahel in Focus: Strengthening the Role of Religious and **Traditional Leaders, Women and Youth**

In May 2024, the Peacemakers Network, in collaboration with the Ministry of Foreign Affairs Finland and the Finnish Embassy to Senegal, convened over 20 religious and traditional leaders, women, and youth representatives from Mali, Niger, Burkina Faso, including the Liptako Gourma region to strengthen their role in conflict prevention and peacebuilding in the Sahel.

This consultative workshop enabled participants to advocate directly with policymakers and civil society, highlighting challenges related to extremist violence and fragile states and identifying their specific support needs. The event also facilitated regional connections, fostering shared learning and common solutions, and provided a platform for participants to present key messages to over 25 international stakeholders, donors, and policymakers. As a result, recommendations and key messages from the participants were produced in English and French.

Supporting the South Sudan Tumaini Peace Process

In 2024, Peacemakers Network and Finn Church Aid supported the role of religious actors in the peaceful transition and in preventing election-related violence. In June, the Peacemakers Network co-organized a Regional Inter-Faith Consultative Dinner Meeting on the South Sudan elections, where esteemed faith leaders from ten African countries were brought together in an effort to amplify the role of religious leaders in mediating peace and addressing the ongoing challenges in South Sudan. The main outcomes of the meeting included a strong commitment from religious leaders to continue collaborating in promoting reconciliation and dialogue in South Sudan.

Religious Actors Advance the Implementation of the **Marrakech Declaration**

As part of the Joint Initiative for Strategic Religious Action Programme (JISRA) a two-day consultation in Addis Ababa, Ethiopia, convened over 20 religious leaders and actors from across Sub-Saharan Africa.



These leaders represented diverse communities and worked to advance the implementation of the Marrakech Declaration (2016). This Declaration was issued by over 300 Muslim scholars, politicians, activists, and interfaith observers as a concerted response to the persecution and violence against ethnic and religious minorities in Muslim-majority states.

Women of Faith Conference: Advocating for Freedom of Religion and Belief in Africa

In June 2024, in partnership with the JISRA Project, the Interreligious Council of Kenya, the African Council of Kenya, the African Council of Religious Leaders, and the Ethiopian Interfaith Forum participated in the Development, Dialogue and Action for the Women of Faith Conference focusing on advancing freedom of religion and belief in Africa.



The Conference held in Addis Ababa, Ethiopia, provided the opportunity for 24 women of faith from Africa, representing diverse religious traditions to increase their capacity in advocacy training as well as advocacy efforts towards the African Union and other international stakeholders. Further, a one-day training was held on women faith-based mediation, engaging the Political Affairs, Peace and Security division of the African Union within the training. The Conference ended with a press conference, producing a statement on ending female genital mutilation.

Bridging Faith and Peace: Insights from the 2024 Religion and Mediation Course in Zanzibar

In September 2024, the Religion and Mediation Course (RMC) equipped 35 participants with tools to analyze the religious dimensions of armed conflicts on the Horn of Africa and the Swahili-speaking Cost of East Africa, with case studies from Somalia, Tanzania, and Kenya. The course facilitated a cross-regional exchange on practical ways of engaging with religion in mediation processes and peacebuilding efforts.



The learning emerging from this course is expected to contribute to the development of widely acceptable governance and peaceful co-existence between communities with different religious and traditional backgrounds. The course was organized together with the Culture and Religion in Mediation Program (CARIM) at the Center for Security Studies ETH Zurich (ETH-CSS), the Swiss Federal Department of Foreign Affairs (FDFA), and the Ministry for Foreign Affairs of Finland (MFA Finland).

Supporting National Reconciliation Through Psychosocial Support, Trauma Healing, and Conflict Resolution and Peacemaking Circles in Somalia

Since 2021, FCA Somalia and the Peacemakers Network have been implementing the MIDDEYE project, meaning "unifier" in Somali, to promote national reconciliation and inclusive governance across Somalia. In collaboration with the Somali Gender Equity Movement, four regional trainings focused on conflict resolution and peacemaking circles, building the capacity of women, the Federal Government of Somalia (FGS), Federal Member States (FMS), and Civil Society Organizations (CSOs).




In partnership with Green String Network, four psychosocial support and trauma healing sessions trained on the Well-being and Resilience Framework, a healing-focused peacebuilding approach. These sessions engaged key stakeholders, including the Ministry of Interior, Federal Affairs and Reconciliation (MoIFAR), Ministry of Women and Human Rights, Ministry of Youth and Sports, civil society, traditional elders, and religious leaders, to address the impact of stress and trauma in violence-prone environments.

Europe, Middle East and North Africa

Support Initiatives in Ukraine for Resilience and Interfaith Cooperation

Ukrainian religious leaders, actors and peacemakers were supported in working together more effectively both locally and nationally by convening different collaborative initiatives such as consultation and workshops. The Peacemakers Network's engagement throughout 2024 aimed at supporting Ukrainian communities, including religious communities to have increased resilience in the prolonged war context as well as assisting religious peacemakers in gaining recognition and resources.

Asia Small Grants Trained 170 Youth from Across the Region

In 2024, the Peacemakers Network provided small grants to four youth-led projects advancing peace across Asia. In Pakistan, Beydaar Society/Brhythm Creatives trained young religious leaders and activists to counter religiously motivated terrorism through networking and digital campaigns. Digital4Peace Foundation in Thailand equipped youth with media literacy skills to combat misinformation and foster interfaith dialogue. The Myanmar Youth Foundation focused on mental health resilience and interfaith collaboration for Burmese youth along the Myanmar-Southern Thailand border. In India, Youth for Peace International empowered youth leaders in Jaipur to address violence through peace education and community dialogue. These initiatives reflect the Network's commitment to innovative, grassroots peacebuilding.



Lessons for Addressing Myanmar's Mental Health Crisis

In partnership with the United States Institute of Peace (USIP) a Focus Group Discussion and Community Readiness Assessment Validation Session was held in March 2024 to inform the 'Mental Health and Psychosocial Support (MHPSS) for Displaced Trauma Survivors from Burma' project. Regional actors, including religious actors who serve in conflictaffected communities, generated recommendations, delivering culturally and religiously sensitive recommendations for MHPSS interventions including addressing basic needs and operational constraints, youth support, generational trauma, community-based solutions, culture and gender sensitivity, and addressing stigma surrounding mental health.



Town Hall on Exploring the Role of Religious Actors in MHPSS and Conflict **Transformation**

The United States Institute of Peace (USIP) and the Peacemakers Network held a 'Mental Health and Psychosocial Support (MHPSS) Town Hall' meeting in August 2024, which shed light on the critical role of religious faith in mental health support for conflict-affected communities. The Town Hall featured case studies from Myanmar, Latin America, and Kashmir, centering discussions on how religious leaders can help heal trauma and foster resilience. With over 30 participants sharing insights, the Town Hall emphasized the importance of collaboration between mental health professionals and faith-based actors.

Working Groups

Africa Working Group

The Africa Working Group hosted more than 170 than 170 individuals working with peace and conflict prevention in Africa. The first meeting of the year was co-hosted with South Sudan Council of Churches (SSCC) and focused on 'Supporting Religious Actors for Peaceful Elections in Sub-Saharan Africa.' Participants explored the impact of religious and traditional actors on peacebuilding in South Sudan and shared reflections from their own context working with religious leaders, women, and youth in creating supportive, safe, and transparent election processes. Building on the findings from the synthesis paper 'Under Crossfire: The Courageous Work of Women Faith-Based Mediators (WFBMs) to Prevent, Mitigate and Resolve Violent Conflict' from the Peacemakers Network and Berghof Foundation WFBM project, the second working group held a deep-dive session to examine 'The Vital Role of Women Mediators in Conflict Resolution' in the context of Cameroon, Nigeria, and Uganda. The working group's final meeting of the year focused on 'Youth's Role in Peacebuilding and P/CVE,' where discussions revealed critical insights into the evolving challenges and opportunities for youth in peacebuilding and preventing violent extremism.





Asia Working Group

The Asia Working Group 2024 annual plan advanced three thematic focuses: 1) the Women, Peace, and Security (WPS) and Youth, Peace, and Security (YPS) agendas; 2) responding to AWG members' country contexts; and 3) protection of persons engaged in interfaith actions (including attention to psychosocial support). Throughout 2024, AWG members collaborated in developing a WPS/YPS guide through survey, interviews and focus group discussions. The guide will be completed in early 2025 to inform AWG work in this area and broader peacebuilding efforts.

Europe and Middle East and North Africa (MENA) Working Group

The Europe and MENA Working Group met for joint reflection and sharing on the escalation of the Israel-Palestine conflict by sharing concrete scriptural and theological examples in how to create an interfaith narrative of peace.






Inclusivity-based Community of Practice (CoP)

Led by its <u>Steering Committee</u>, the Inclusivity Community of Practice delved into pivotal discussions and actions centered on fostering inclusivity across multiple fronts. The first meeting of the year focused on 'Promoting the Freedom of Religion and Belief Through the Inclusion of Religious Minorities in Peacebuilding', and provided a space where members of the CoP shared <u>how they are advancing the inclusion of religious minorities</u> in their work. With emerging themes like tech and Al being more integrated into peace work, the CoP explored opportunities to 'Synergize Peace Tech, Inclusion and SDG 16 in Connection to the Multi-Stakeholder Forum on Science, Technology, and Innovation for the SDGs', aiming to <u>understand how peace tech can advance inclusion in peacebuilding</u>. The group also explored <u>how faith and LGBTQ+ communities can form better partnerships</u> to 'Advance the Inclusion and Rights of LGBTQ+ of Faith in Peacebuilding', while utilizing the Queering the Women, Peace and Security toolkit, a resource identified from CSW68 engagements. Finally, the CoP convened with Traditional and Indigenous peacebuilders and leaders to learn how we can 'Strengthen the Inclusion of Traditional and Indigenous Peoples in Peacebuilding Efforts,' and <u>form stronger partnerships with Indigenous and Traditional communities and peace organizations</u>.
