## INTRODUCTION

Freedom of Religion or Belief (FoRB) remains a cornerstone of peaceful, inclusive, and resilient societies. Advancing FoRB is not only a moral and legal obligation but a strategic investment in social cohesion, democratic governance, and long-term stability. Recognizing the urgency to translate commitments into transformative action, the Dutch-funded Joint Initiative for Strategic Religious Action (JISRA) is dedicated to advancing the principles enshrined in the 2016 Marrakesh Declaration — particularly the protection of religious minorities in Muslim-majority contexts and the promotion of equal citizenship for all.

This situational analysis, informed by assessments across Ethiopia, Indonesia, Iraq, Kenya, Mali, Nigeria, and Uganda, provides an evidence-based overview of the evolving FoRB landscape. It identifies persistent challenges, emerging opportunities, and critical intervention points. Importantly, it outlines actionable, country-specific priorities that will enable implementers, donors, policymakers, and civil society actors to drive forward the Marrakesh Declaration's vision in ways that are locally rooted, context-sensitive, and strategically coordinated.

To realize the objectives of the Marrakesh Declaration over the next decade, it is essential to develop tailored national roadmaps and action plans that align with each country's specific political, social, and religious dynamics. These plans will serve as guiding instruments to operationalize commitments, prioritize catalytic interventions, and measure progress toward the sustainable institutionalization of FoRB principles.

Through this approach, JISRA reaffirms its commitment to a holistic, multi-sphere strategy: challenging discrimination and extremism within religious communities (intrareligious sphere), strengthening bridges of solidarity between faith groups (interreligious sphere), and engaging state and international actors to ensure structural and policy reforms (extra-religious sphere). By grounding interventions in local realities while adhering to the universal aspirations of the Marrakesh Declaration, JISRA and its partners aim to forge a future where freedom of belief is protected, diversity is celebrated, and peace is enduring.

# COUNTRY CASE STUDIES AND COUNTRY-SPECIFIC PRIORITIES

Effective implementation of the Marrakesh Declaration requires approaches that are not only globally inspired but also meticulously tailored to each country's unique political, social, and religious landscapes. In recognition of this, JISRA has strategically collaborated with national partners to identify and co-create priority actions that reflect the Marrakesh Declaration's shared principles while addressing complex local realities.

These country-level strategies are grounded in rigorous, context-driven assessments and are designed to translate the Marrakesh Declaration's commitments into tangible, measurable outcomes. They aim to protect religious minorities, strengthen inclusive citizenship, and advance FoRB, thereby laying critical foundations for resilient, peaceful, and pluralistic societies.

The priority interventions outlined below highlight highimpact strategic entry points, ranging from comprehensive legal and policy reform, civic and interfaith education integration, to grassroots dialogue mechanisms and advanced early warning systems. Each initiative is deliberately designed to be locally owned, gender-responsive, and rooted in faith-based and community legitimacy, ensuring both cultural resonance and long-term sustainability. For strategic stakeholders, these initiatives provide clear, evidence-based pathways to achieve scalable and systemic impact. By engaging with and supporting these context-specific strategies, partners can directly contribute to transforming the Marrakesh Declaration into a dynamic, operational tool for fostering coexistence, justice, and peace.

The countries profiled below illustrate diverse, locally led approaches to embedding FoRB principles within national governance and community systems. These efforts build on the strong foundations established through JISRA-supported faith structures and partnerships, which concluded in July 2025, representing a compelling opportunity for strategic collaboration toward shared global objectives of promoting religious freedom and fostering inclusive, peaceful societies.

Indonesia	Amplify inclusive and pluralistic religious narratives through strategic media engagement; scale multi-faith civic education programs to cultivate a culture of tolerance and mutual respect; and establish comprehensive monitoring and reporting systems to identify and address discrimination proactively.
Iraq	Pursue comprehensive legal reforms to ensure robust protection of religious and ethnic minorities; engage faith actors as key partners in national reconciliation processes; and support grassroots-level peace dialogues to rebuild trust and foster social cohesion in post-conflict settings.
Kenya	Institutionalize interfaith platforms at county and national levels to promote sustained dialogue and collaboration; integrate FoRB principles into civic education curricula to shape inclusive citizenship; and implement targeted awareness campaigns to empower youth and women as champions of religious freedom and peaceful coexistence.
Mali	Strengthen and expand interfaith dialogue initiatives as critical instruments for preventing violent extremism; enhance the capacity of religious leaders to serve as proactive agents in countering extremist narratives; and integrate FoRB frameworks into national stabilization and peacebuilding strategies.
Nigeria	Formulate and implement a comprehensive national FoRB policy framework; introduce trauma-informed educational approaches to address the psychosocial needs of conflict-affected communities; and foster systematic collaboration between religious and traditional leaders, youth, and security actors to build trust and resilience.
Uganda	Expand specialized FoRB training programs targeting religious and traditional leaders to enhance community leadership on religious freedoml establish community-based early warning and response systems to strengthen local peace infrastructures; and mainstream FoRB principles into national development planning and implementation frameworks to ensure inclusive and sustainable societal transformation.

# **Ethiopia**

Implementing the Marrakesh Declaration in Ethiopia presents a complex yet transformative landscape, characterised by both persistent challenges and catalytic opportunities. Ongoing political involvement in religious affairs, including state interference in the selection of religious leadership and the governance of faith-based institutions, undermines the autonomy of religious communities and threatens the realisation of FoRB commitments. Additionally, a limited understanding and internalisation of the Marrakesh Declaration's core principles, equal citizenship, minority rights protection, and interfaith coexistence, constrain the capacity of religious and civil society actors to advocate for and operationalise FoRB effectively.

Nevertheless, Ethiopia's constitutional framework provides a robust legal foundation for the protection of religious rights. At the same time, active interfaith platforms serve as dynamic entry points for advancing dialogue, joint advocacy, and collaborative action. To fully harness these enabling conditions and address the systemic barriers, a set of strategic, high-impact interventions is proposed. Specifically, Ethiopia should advance nationwide legal literacy initiatives to empower communities with knowledge of their rights and protections; institutionalise interfaith platforms as permanent, resilient mechanisms for sustained dialogue and social cohesion; and strengthen the advocacy capacity of religious leaders to influence policy, mobilise constituencies, and effectively counter divisive narratives. These integrated, multi-level strategies will collectively create a conducive ecosystem for realising the transformative vision of the Marrakesh Declaration and fostering a peaceful, just, and inclusive society.

To fully harness these opportunities and address the prevailing challenges, a comprehensive set of integrated, high-impact strategic interventions is proposed to create an enabling environment for advancing FoRB and realising the transformative vision of the Marrakesh Declaration.

# Strategic Recommendations for Implementing the Marrakesh Declaration to Advance FoRB in Ethiopia

Invest in Targeted Capacity Strengthening			
Action	Design and implement comprehensive training programs for Muslim religious leaders, women, youth, and civil society actors, emphasising FoRB principles rooted in Islamic teachings that promote pluralism, justice, and peaceful coexistence.		
Objective	To empower influential actors with contextualized, rights-based theological frameworks and tailored advocacy tools to effectively localize, operationalize, and advance the principles of the Marrakesh Declaration within their communities.		
Recommendation	Develop localized FoRB training toolkits that are carefully contextualized to Ethiopia's diverse religious, cultural, and linguistic landscapes, ensuring relevance, inclusivity, and practical applicability at the community level.		

# Launch a Straegic Communications and Media Engagement Campaign

#### Action

Translate the core messages of the Marrakesh Declaration into Amharic, Afaan Oromo, and Tigrinya, and strategically disseminate them through religious radio stations, national and community broadcasters, digital media platforms, and community theatre networks to ensure broad, culturally resonant, and inclusive outreach across Ethiopia's diverse populations.

#### Objective

To empower influential actors with contextualized, rights-based theological frameworks and tailored advocacy tools to effectively localize, operationalize, and advance the Marrakesh Declaration within their respective communities.

#### Recommendation

Establish strategic partnerships with credible media institutions and respected faith-based influencers to cocreate and disseminate accessible, culturally resonant narratives that highlight the transformative benefits of religious freedom for fostering national unity, social cohesion, and sustainable development.

# Institutionalize the Marrakesh Declaration's Principles within National Religious Structures

#### Action

Forge formalized, strategic partnerships with the Ethiopian Inter-Religious Council and other leading faith-based organizations to systematically embed the principles of the Marrakesh Declaration within their institutional programming, strategic frameworks, and government advisory functions.

#### Objective

To cultivate resilient, institutional champions for FoRB, ensuring long-term sustainability and impact that transcends individual project cycles.

#### Recommendation

Support the co-creation of comprehensive interfaith action plans that are fully aligned with the Marrakesh Declaration's vision and Ethiopia's constitutional commitments, thereby reinforcing cohesive, rights-based approaches at both policy and community levels.

Strengthen Legal Literacy and Access to Justice				
Action	Launch comprehensive grassroots legal literacy campaigns to educate communities on constitutional protections for FoRB and available mechanisms for redress in cases of discrimination or interference.

Recommendation	Support and scale mobile legal clinics, paralegal networks, and context-sensitive civic education programs specifically tailored to reach rural and underserved populations, ensuring equitable access to justice and fostering inclusive, rights-based community environments.

To foster broad-based consensus, enhance mutual accountability, and catalyse Objective coordinated collective action towards the effective implementation of the Marrakesh Declaration. Establish a National FoRB Advocacy Coalition to harmonize efforts, facilitate Recommendation knowledge exchange and best practice sharing, and strategically influence policy and legislative reform agendas.

Recommendation	Forge strategic partnerships with women-led religious and interfaith organizations to mainstream gender-responsive approaches and embed gender equity throughout all programmatic and policy levels.		

Advancing the Marrakesh Declaration in Ethiopia necessitates an integrated, multi-dimensional strategy that seamlessly aligns constitutional protections with grassroots mobilisation and institutional anchoring. By investing in targeted capacity strengthening for religious and civil society actors, advancing strategic legal literacy and empowerment initiatives, institutionalizing resilient interfaith platforms, and fostering inclusive policy dialogue, Ethiopia can transform its rich pluralistic heritage into a dynamic engine for advancing FoRB, strengthening social cohesion, and promoting inclusive citizenship.

Policymakers and donor organisations play a pivotal enabling role in actualising this transformative vision. Through strategic, sustained investments, high-level diplomatic engagement, and robust support for locally led initiatives, they can catalyse a broad-based national movement toward a more peaceful, just, and inclusive Ethiopia fully aligned with the spirit and commitments of the Marrakesh Declaration.

**Key institutions to take forward the recommendations:** The Inter-Religious Council of Ethiopia, Ethiopia Interfaith Forum for Development, Dialogue & Action (EIFDDA), Ethiopia Women of Faith and Interfaith Youth Networks.

# Kenya

Kenya offers a dynamic context marked by both persistent challenges and significant opportunities for advancing and operationalising the Marrakesh Declaration's vision of inclusive citizenship, religious minority protection, and FoRB. A key structural barrier remains the limited dissemination and internalisation of the Marrakesh Declaration's principles beyond urban and elite circles into grassroots communities. Rural constituencies, informal settlements, and traditional governance systems often lack awareness of and engagement with core tenets such as equal citizenship and religious pluralism. Moreover, the continued politicisation of religious and ethnic identities political actors seeking to consolidate power undermines FoRB efforts, delegitimises interfaith initiatives, entrenches exclusionary narratives, and exacerbates intercommunal tensions.

Nevertheless, Kenya's robust civic space and established interfaith networks present catalytic entry points for transformative progress. Initiatives such as the Women of Faith Network-Kenya, Building Resilience in Diverse Communities through Grassroots Engagement (BRIDGE), and Twaweza exemplify strong capacities for crossreligious solidarity, community resilience, and rights-based advocacy. In addition, the constitutional quarantees for FoRB, enshrined in Article 32 of the Kenyan Constitution (2010), offer a powerful legal foundation for embedding the Marrakesh Declaration's principles into national legislative and policy frameworks. By strategically leveraging these assets, Kenya can serve as a model for integrating FoRB into inclusive governance and social cohesion agendas, thereby advancing a more just, peaceful, and pluralistic society that is fully aligned with the Marrakesh Declaration's transformative vision.

### Strategic Recommendations for Advancing FoRB through Implementation of the Marrakesh Declaration

## **Curriculum Integration and Civic Education** Establish strategic partnerships with the Ministry of Education, Kenya Institute of Curriculum Development (KICD), and major faith-based education networks Action to systematically integrate FoRB and Marrakesh Declaration principles into national, religious, and supplementary educational curricula. To institutionalize the values of inclusive citizenship, human dignity, religious tolerance, and Objective non-discrimination among the next generation, creating a foundation for sustained societal transformation. Co-develop age-appropriate curricular content and comprehensive teacher training modules for madrasas, Sunday schools, and formal education Recommendation systems. Embed human rights education aligned with Article 32 of the Kenyan Constitution and the Marrakesh Declaration to promote rights-based learning from an early age.

#### Institutionalisation through Faith Councils

#### Action

Mobilise major religious councils including Supreme Council of Kenyan Muslims (SUPKEM), National Council of Churches in Kenya (NCCK), the Hindu Council of Kenya, and evangelical alliances to formally endorse and adopt the Marrakesh Declaration as a guiding framework for interfaith and intra-faith engagements.

#### Objective

To foster broad-based faith ownership of FoRB principles and establish self-sustaining, institutional mechanisms for interreligious collaboration and advocacy at both national and community levels.

#### Recommendation

Facilitate the development of joint declarations, codes of conduct, and internal organizational charters that embody the Marrakesh Declaration's values. Organize formal endorsement and public commitment ceremonies to enhance visibility, legitimacy, and societal impact.

#### Monitoring, Evaluation, and Learning (MEL) Systems

By embedding implementation within Kenya's robust interfaith networks, leveraging mobile and digital technologies for widespread grassroots awareness and education, and adopting a gender-responsive and rightsbased approach, Kenya is well-positioned to operationalise and scale the principles of the Marrakesh Declaration. Anchoring these efforts within comprehensive policy and legislative frameworks further strengthens institutional accountability and sustainability. This integrated strategy not only consolidates social cohesion and advances freedom of religion or belief domestically but also positions Kenya as a regional exemplar and influential advocate for peaceful, inclusive, and pluralistic societies across the Horn of Africa. Through adaptive, evidencedriven MEL systems, Kenya can continuously measure progress, inform policy refinement, and catalyse broader regional learning and replication.

Key institutions to take forward the recommendations: Inter-Religious Council of Kenya, Muslims for Human Rights (MUHURI), Supreme Council of Kenya Muslims (SUPKEM), Jamia Mosque, County Engagement Forums in Nairobi, Northeastern and Coast Counties, Coast Interfaith Council of Clerics (CICC).

# **Uganda**

FBOs and civil society actors in Uganda have emerged as critical catalysts in advancing grassroots education and advocacy on FoRB. Through targeted awareness campaigns and community centred initiatives, these actors have created safe, inclusive spaces that foster religious tolerance, interfaith solidarity, and peaceful coexistence among diverse faith communities. Their work, deeply grounded in relational trust and contextual legitimacy, effectively translates universal human rights principles into locally relevant, actionable narratives that resonate with community values.

Building on this strong foundation, Uganda presents significant strategic opportunities to advance the principles of the Marrakesh Declaration. Active interfaith networks, such as the Uganda Joint Christian Council (UJCC) and the Inter-Religious Council of Uganda (IRCU), provide established, institutionalised platforms capable of convening diverse religious actors around a unified FoRB agenda. The country's constitutional guarantees of freedom of conscience and religion further reinforce a favourable policy environment for mainstreaming the Marrakesh Declaration's values into national governance and civic life.

However, critical challenges persist, including entrenched religious rivalries rooted in historical grievances, politicisation of religion during electoral cycles, and limited public understanding of FoRB rights and protections. Addressing these barriers requires a comprehensive, multi-dimensional, and locally led strategy that integrates capacity strengthening, inclusive policy dialogue, strategic communication, and sustained community engagement. By adopting such an approach, Uganda can not only advance domestic social cohesion and inclusive citizenship but also position itself as a regional leader and exemplar in promoting peaceful, pluralistic societies aligned with global FoRB commitments and the transformative vision of the Marrakesh Declaration.

#### Strategic Interventions for Advancing FoRB in Uganda

Expand FoRB-Focused Training for Religious and Traditional Leaders

Action

Design and implement comprehensive, systematic capacity-building programs for religious and traditional leaders, equipping them with in-depth knowledge of FoRB principles and practical, context-sensitive advocacy skills to effectively promote inclusive, rights-based approaches within their communities.

Objective

To empower trusted community influencers with advanced, rights-based skills and contextually relevant strategies to challenge religious intolerance, promote diversity, and serve as proactive early responders to emerging tensions and act as early responders to emerging tensions.

Recommendation

Establish strategic partnerships with interfaith councils to cocreate and deliver tailored FoRB capacity-building modules, fully contextualized to Uganda's socio-religious and political realities, ensuring local ownership and cultural resonance.

### **Priority Stakeholders**

The successful implementation of the Marrakesh Declaration in Uganda depends on mobilising a core group of strategic enablers, including religious leaders, interfaith networks, civil society actors, government human rights agencies, media platforms, and local community champions. These enablers are vital in fostering local ownership, strengthening institutional frameworks, and ensuring continuous capacity development at all levels. By integrating FoRB principles into national policies and community-based structures, Uganda can sustain the Marrakesh Declaration's legacy beyond initial phases and support its wider goals of social cohesion, inclusive governance, and democratic resilience. Leveraging the collective influence and expertise of these enablers positions Uganda to become a regional leader in promoting religious pluralism, justice, and sustainable peace.

**Key institutions to take forward the recommendations:** Uganda Muslim Supreme Council (UMSC), Western Uganda Faith based organizations Network, Koogere Foundation, Muslim Youth in Uganda, The Muslim Association at the Mountain of the Moon University.

## Mali

Mali's once-strong traditions of religious coexistence have been severely undermined by the declining security environment driven by violent extremism. In regions affected by conflict, increasing religious tensions diminish community resilience, disrupt intercommunal relations, and heighten mistrust. The decline of traditional conflict resolution mechanisms has created an urgent need for renewed efforts to promote FoRB as a basis for lasting peace.

To address these challenges and advance the Marrakesh Declaration's vision, Mali must adopt a strategic and conflict-sensitive approach that strengthens interfaith collaboration, counters extremist narratives, and embeds the promotion of FoRB within broader stabilisation frameworks.

# Nigeria

Nigeria represents one of the most intricate and high-stakes contexts for advancing FoRB. Deep-seated religious and ethnic cleavages, particularly pronounced in the Middle Belt and Northern regions — continue to drive intercommunal tensions, cyclical violence, and widespread societal fragmentation. While Nigeria benefits from a robust ecosystem of interfaith platforms dedicated to dialogue and reconciliation, persistent impunity for religiously motivated violence and inadequate enforcement of legal protections undermine public trust and perpetuate cycles of retribution.

Implementing the vision of the Marrakesh Declaration in Nigeria requires a comprehensive, multi-tiered, and conflict-sensitive in strategy grounded systemic transformation. This strategy must prioritise institutional and legal reforms to strengthen the rule of law and accountability frameworks; promote psychosocial healing address intergenerational trauma and rebuild intercommunal trust; and foster grassroots empowerment to enhance community-led resilience and locally owned peacebuilding mechanisms. Furthermore, cultivating strategic partnerships with faith-based actors, civil society organisations, and state institutions is essential to creating enabling environment for sustained FoRB advancement.

Nigeria's long-term stability and social cohesion are contingent upon integrating FoRB as a foundational pillar of national peace and security policies, bridging legal protections with psychosocial interventions, and fostering inclusive governance structures that reinforce pluralism and equal citizenship.

## Indonesia

Indonesia's national philosophy, Pancasila, formally enshrines religious diversity and pluralism as core pillars of its national identity. However, despite strong constitutional guarantees, religious minorities continue to encounter systemic discrimination, social marginalisation, and periodic violence. The inconsistent enforcement of legal protections is often influenced by political expediency and entrenched societal biases that perpetuate a persistent gap between normative commitments and lived realities. This disjuncture undermines Indonesia's social cohesion and threatens the inclusive ethos foundational to its national unity.

Advancing the vision of the Marrakesh Declaration in Indonesia requires a comprehensive, multi-dimensional, and sustained strategy. This strategy must prioritise the promotion of inclusive and pluralistic narratives, institutionalise robust legal and policy frameworks safeguarding FoRB, and deepen grassroots engagement to local ownership and resilience. Strategic interventions should include strengthening the rule of law mechanisms, enhancing interfaith and intercultural dialogue, empowering vulnerable and communities, and fostering cross-sectoral partnerships that bridge government, civil society, and religious institutions.

Through deliberate and coordinated action across these domains, Indonesia can close the gap between constitutional ideals and societal practice, reinforcing its commitment to pluralism and laying a stronger foundation for durable peace and inclusive national development.

In doing so, Indonesia will not only reaffirm its dedication to religious freedom but also fortify the spirit of Pancasila and embody the principles of the Marrakesh Declaration, laying a resilient foundation for inclusive, peaceful, and democratic national development.

## Iraq

Iraq's religious and social fabric remains profoundly fractured because of decades of violent sectarian conflict. While recent political transitions have created openings for interfaith dialogue and national reconciliation initiatives, religious minorities continue to experience systemic discrimination, forced displacement, and targeted violence. The persistent politicisation of religious identity, frequently instrumentalised for political gain, continues to undermine efforts to foster an inclusive, unified, and democratic Iraqi society.

Strengthening FoRB in Iraq requires a comprehensive, multi-dimensional roadmap that simultaneously addresses legal, social, and political drivers of intolerance while empowering local actors to rebuild relationships across sectarian divides. This strategic approach should prioritise institutional reforms to consolidate legal protections and reinforce accountability mechanisms, alongside social norm transformation initiatives aimed at rebuilding trust and nurturing intercommunal relationships. Furthermore, it should empower religious leaders, youth, and civil society as key stakeholders in peacebuilding and embed FoRB objectives within national reconciliation and development agendas.

By operationalising such a coordinated and contextsensitive strategy, Iraq can begin to bridge deep societal divides, consolidate an inclusive national identity, and lay the foundation for a peaceful, pluralistic, and resilient future.

By rooting FoRB initiatives firmly within Iraq's unique social, cultural, and political context and integrating lessons learned from local experiences, stakeholders can create pathways for meaningful and lasting change.

Through this coordinated and context-sensitive approach, Iraq can begin to rebuild trust across sectarian divides, consolidate an inclusive national identity, and create a resilient, peaceful society where religious diversity is both protected and celebrated as a vital pillar of national unity and future stability.
